- 3) The conversion of the Corporation has been approved in accordance with the provisions Subtitle 9 of the Maryland General Corporation Law.

- 5) These Articles of Conversion shall be effective December 26, 2019. /

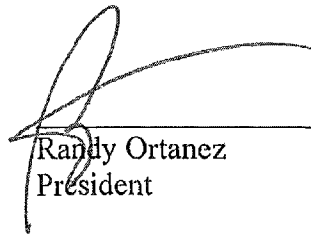
