


## CONFIRMATORY ASSIGNMENT

The transfer also includes all income, royalties, damages, or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present, or future infringement, of the rights, with the right to sue for and collect the same for Assignee’s use and enjoyment.
