Pursuant to Section 251 of the General Corporation Law of the State of Delaware, the undersigned surviving corporation submits the following Certificate of Merger for filing and does hereby certify that:

FIRST: The name and state of incorporation of each of the constituent corporations is as follows:

- (a) Lightspeed NuORDER Inc., a corporation organized and existing under the laws of the State of Delaware ("Second Merger Sub"); and
- (b) NuORDER, Inc., a corporation organized and existing under the laws of the State of Delaware ("NuORDER").

SECOND: The Agreement and Plan of Merger, by and among Lightspeed POS Inc., Umbrella Merger Sub Inc., Second Merger Sub, NuORDER, and the Stockholders' Representative named therein, dated as of June 6, 2021 (as amended, restated or supplemented from time to time, the "Merger Agreement"), has been approved, adopted, executed and acknowledged by Second Merger Sub and NuORDER in accordance with the requirements of Section 251(c) of the General Corporation Law of the State of Delaware.

THIRD: The name of the surviving corporation is Lightspeed NuORDER Inc. (the "Surviving Corporation").

FOURTH: The certificate of incorporation of Lightspeed NuORDER Inc. shall be the certificate of incorporation of the Surviving Corporation.

FIFTH: The executed Merger Agreement is on file at the place of business of the Surviving Corporation at 700 St-Antoine E, Suite 300, Montreal, QC H2Y 1A6, Canada.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either Second Merger Sub or NuORDER.

SEVENTH: That this Certificate of Merger shall become effective upon filing hereof with the Secretary of State of the State of Delaware.
