RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of July 1, 2021 (this “Release”), delivered by The Bank of New York Mellon Trust Company, N.A. (“BNY”), as Collateral Agent under the Security Agreements referenced below.

A. Reference is made to (a) the Indenture dated as of April 27, 2020 (the “Indenture”), among Navistar International Corporation (the “Issuer”), the guarantors party thereto, and BNY, as Trustee, (b) the 9.500% Senior Secured Notes Second Lien and Third Lien Security Agreement (the “Collateral Agreement”) dated as of April 27, 2020, among the Issuer, certain subsidiaries of the Issuer from time to time party thereto and BNY, as Collateral Agent and (c) the Patent and Trademark Security Agreement, dated as of April 27, 2020, among Issuer, Navistar, Inc. (“Navistar”), the other subsidiaries of the Issuer from time to time party hereto (together with the Issuer and Navistar, the “Pledgors”) and BNY, as Collateral Agent, which was recorded with the United States Patent and Trademark Office at Reel 6924 Frame 0271 (the “2020 PTSA”) and together with the Collateral Agreement, the “Security Agreements”). Capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Indenture or the Security Agreements, as applicable.

B. Pursuant to the Security Agreements, the Pledgors granted a security interest to the Collateral Agent, for the benefit of the Notes Secured Parties, in, among other things, the trademarks of the Pledgors set forth on Schedule I hereto (the “Trademarks”).

C. In connection with the payment and discharge of all Obligations of the Pledgors and the termination of all Commitments under the Indenture and related documents, the Pledgors have informed the Collateral Agent of their desire that the Collateral Agent, on behalf of the Notes Secured Parties, release all right, title and interest granted to it, for the ratable benefit of the Notes Secured Parties, under the Security Agreements in and to the Trademarks.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (a) terminates, releases and discharges any and all security interests it has in the Trademarks and reassigns all right, title and interest it has in the Trademarks, together with the goodwill associated therewith, to the applicable Pledgor and (b) terminates the 2020 PTSA. The execution and delivery of this Release and the performance of any actions by the Collateral Agent are made without representation or warranty by, or recourse to, the Collateral Agent or any other Notes Secured Party.
