TRADEMARK ASSIGNMENT



- 2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the SAFFIRO (Stylized) trademark, including without limitation, damages, and payments for past or future infringements and misappropriations of the SAFFIRO (Stylized) trademark, and
- 3) all rights to sue for past, present and future infringement or misappropriations of the SAFFIRO (Stylized) trademark.

The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the SAFFIRO (Stylized) trademark and its related property.
