WHEREAS, Assignor has adopted and used in its business the trademarks set forth on the attached Schedule 1; and


WHEREAS, Assignee is desirous of acquiring said marks.

IN WITNESS WHEREOF, Assignor and Assignee have duly executed this Assignment as of the date set forth above.


