**Intellectual Property Assignment  
(EPIC VENTURES, INC.)**

**THIS INTELLECTUAL PROPERTY ASSIGNMENT** (“Assignment”), effective as of April 12, 2021 (“Effective Date”), is made and entered into by Epic Ventures, Inc., a California corporation (“Assignor”), in favor of Southern Glazer’s Wine and Spirits, LLC, a Delaware limited liability company (“Assignee”).

**WHEREAS**, Assignor is the owner of the following service marks (the “Marks”) containing the registrations noted (the “Registrations”) (i) the service mark “Epic Wines & Spirits”, a service mark that is the subject of common law rights and a registration with the U.S. Patent and Trademark Office, Registration No. 5,627,400, and (ii) the service mark “Epic Wines”, a service mark that is the subject of common law rights and a registration with the U.S. Patent and Trademark Office, Registration No. 4,150,101, and (iii) certain other Intellectual Property Assets, as such term is defined in the Asset Purchase Agreement dated as of February 5, 2021 by and between Assignor, Assignee and the other party thereto, as amended by that certain Amendment to Asset Purchase Agreement dated as of April 12, 2021.

**WHEREAS**, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all right, title and interest in and to the Marks and Registrations, the Intellectual Property Assets, together with the goodwill of Assignor’s business associated with the Marks and Registrations; and


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby assigns, sells and sets over to Assignee all right, title and interest in and to the Marks and Registrations, the Intellectual Property Assets, together with the goodwill of Assignor’s business symbolized by the Marks and Registrations and Intellectual Property Asset.

2. Assignor authorizes the Commissioner for Patents, the Commissioner for Trademarks and any other governmental officials to record and register this Assignment upon request by Assignee. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
