RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "*Release*"), dated as of July 14, 2021, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION (as successor by merger to Wells Fargo Retail Finance, LLC) ("*Agent*"), in favor of BEVERAGES & MORE, INC., Delaware corporation ("*Borrower*").

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement, dated as of February 27, 2007 (as amended, restated, supplemented and otherwise modified from time to time, the "*Agreement*"; capitalized terms used herein shall have the meanings ascribed thereto in the Agreement unless defined herein), recorded with the U.S. Patent and Trademark Office on March 5, 2007 at Reel 003493, Frame 0359, in which Borrower pledged and granted to Agent a security interest in and to all of the right, title and interest of Borrower in, to and under the Trademark Collateral, wherever located, and whether then existing or thereafter arising or acquired from time to time;

WHEREAS, Borrower requested that Agent release, discharge, terminate and cancel its security interest in and to the trademark registrations and applications listed on Schedule I attached hereto (the "*Trademarks*") and all other Trademark Collateral, including the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent, without recourse, representation or warranty of any kind or nature, and at Borrower's sole cost and expense, hereby releases, discharges, terminates and cancels its security interest in and to the Trademarks and the other Trademark Collateral.

Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.


