RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“**Release**”), is made and effective as of July 15, 2021 and granted by FIRST EAGLE ALTERNATIVE CAPITAL AGENT, INC., as Agent (f/k/a THL Corporate Finance, Inc.) (the "**Secured Party**"), a Delaware corporation, located at 500 Boylston Street, Suite 1250, Boston, MA 02116 in favor of ACTIVEPDF, INC., a California corporation, and its successors, legal representatives and assignees (collectively, the "**Grantor**").

WHEREAS, Grantor entered into that certain Amended and Restated Credit Agreement, dated as of June 19, 2020 (the "**Loan Agreement**"), with the Secured Party;

WHEREAS, in connection with the Loan Agreement, the Grantor executed and delivered to the Secured Party that certain Trademark Security Agreement, dated as of June 19, 2020 (the "**Trademark Security Agreement**");

WHEREAS, pursuant the Trademark Security Agreement, the Grantor pledged and granted to the Secured Party a security interest in and to all of the right, title and interest of the Grantor in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 6977/ Frame 0988 on June 24, 2020; and

WHEREAS, the Grantor has requested that the Secured Party execute this Release in order to accomplish and evidence the release and reassignment of any and all right, title and interest the Secured Party may have in the Trademark Collateral pursuant to the Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby states as follows:

1. Release of Security Interests. The Secured Party, its successors, legal representatives and assigns, terminates, releases and discharges its security interest in, to and under the Trademark Collateral, and all other right, title, and interest in and to the Trademark Collateral, including the trademarks referred to on Schedule I hereto, and reassigns to the Grantor any and all such right, title and interest that it may have in the Trademark Collateral.
2. Further Assurances. The Secured Party agrees to execute, acknowledge, procure and deliver to the Grantor any and all further documents or instruments and do any and all further

acts which the Grantor (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and the Grantor's (or its assignees') right, title and interest in and to the Trademark Collateral.
