TRADEMARK AND DOMAIN ASSIGNMENT AGREEMENT

This TRADEMARK AND DOMAIN ASSIGNMENT AGREEMENT (this "Assignment") is made as of April 22, 2016 by and between ABG Prince Sports, LLC, a Delaware limited liability company having a business address at 1411 Broadway, 4th floor, New York, New York 10018 ("Assignor"), and Viking Sports, LLC, a Nebraska limited liability company having a business address at 2111 S. 67th Street, Suite 400 Omaha, Nebraska 68106 ("Assignee"). Assignor and Assignee are hereinafter collectively referred to as the "Parties," or individually as a "Party."

WHEREAS, Assignor owns certain rights to the **VIKING** brand, including: (i) the **VIKING** name and mark and  logo, all in connection with certain racquet sports products; and (ii) the following website/domain: www.vikingathletics.com

WHEREAS, Assignor wishes to assign to Assignee all of Assignor's right, title and interest in and to its **VIKING** trademarks and the website/domain, each as set forth on Schedule A-1 hereto, together with the goodwill associated with any of the foregoing and all registrations, applications for registration, renewals and extensions of any of the foregoing (the "Assigned Property").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignment. Assignor does hereby irrevocably sell, assign, convey and transfer to Assignee (i) all its right, title and interest (whether statutory, common law or otherwise) in and to the Assigned Property; and (ii) all claims, causes of action and other legal rights and remedies, whether or not known as of the date hereof, relating to the ownership of the Assigned Property. The foregoing assignment includes the exclusive rights to (a) apply for and maintain all registrations and renewals of the Assigned Property, (b) bring actions or otherwise recover for infringements, dilutions or other violations thereof, and the right to the profits or damages due or accrued, arising out of or in connection with any and all past, present or future infringements, dilutions and other violations of the Assigned Property, and (c) file documents reflecting changes of corporate name or form.
2. Acknowledgement. Assignor hereby acknowledges that from and after the date hereof, Assignee shall be the exclusive owner of all of Assignor's right, title and interest in and to the Assigned Property and the related rights set forth in Section 1 of this Assignment.
3. Further Assurances. Each Party agrees, without any further consideration, to execute and deliver such other documents and to take such other actions as the

other may reasonably request in order to effectuate the purposes of this Agreement and to consummate the actions contemplated hereby, including the execution of any assignment agreement as may be necessary to effectuate, confirm and/or record the assignment granted herein with any applicable government entity.

4. Binding Effect; Assignment. This Assignment shall be binding upon and inure solely to the benefit of the Parties and their respective successors and permitted assigns.
5. Governing Law. This Agreement, and any dispute, claim, legal action, suit, proceeding or controversy (whether in contract or tort) arising out of or relating to this Agreement, or the negotiation, execution or performance of this Agreement (including any cause of action based upon, arising out of or related to any representation or warranty made in or in connection with this Agreement or as an inducement to enter this Agreement), shall be governed by, and construed in accordance with, the laws of New York, United States of America without regard to conflict of law principles thereof.
6. Counterparts; Effectiveness. This Agreement may be executed in any number of counterparts, as if the signatures to each counterpart were upon a single instrument, and all such counterparts together shall be deemed an original of this Agreement. Facsimile signatures or signatures received as a pdf attachment to electronic mail shall be treated as original signatures for all purposes of this Agreement. This Agreement shall become effective when, and only when, each Party has received a counterpart signed by the other Party.


