RELEASE OF SECURITY INTERESTS IN TRADEMARKS

July 16, 2021

WHEREAS, Monroe Capital Holdings LLC, a Delaware limited liability company, pursuant to that certain Intellectual Property Security Agreement, recorded in the United States Patent and Trademark Office on September 8, 2020, at Reel 7046, Frame 0333 (the “**Grantor**”), previously assigned and granted to Ally Bank, as collateral agent (the “**Collateral Agent**”), a security interest in and to all of each Grantor’s right, title and interest in and to the Trademark registrations and Trademark applications specifically listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the “**Marks**”); and

WHEREAS, Collateral Agent wishes to absolutely, unconditionally, irrevocably and forever release, terminate, cancel, and discharge the collateral pledge, grant, assignment, lien and security interest under the aforementioned Intellectual Property Security Agreement and retransfer and reassign to Grantor all of Collateral Agent’s right, title and interest in and to the Marks and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby absolutely, unconditionally, irrevocably and forever releases, terminates, cancels and discharges the collateral pledge, grant, assignment, lien and security interest under the Intellectual Property Security Agreement and retransfers and reassigns to each Grantor all of Collateral Agent’s right, title and interest in and to the Marks and the goodwill associated therewith. Collateral Agent shall execute and deliver to Grantor, at Grantor’s expense, all instruments and documents that are reasonably requested and furnished by Grantor for the purpose of effectuating the intent of this instrument.
