**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, July 19, 2021 ("Release"), is made by Bank of America, N.A., as Administrative Agent ("Administrative Agent") in favor of Detail Garage, LLC, a California limited liability company ("Grantor"). All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement (defined herein) or Notice (defined herein).

WHEREAS, pursuant to that certain Security Agreement dated as of December 13, 2018 (as may have been amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Grantor, Administrative Agent, and others party thereto, Grantor granted and pledged to the Administrative Agent, for the benefit of itself and the Secured Parties, a continuing security interest in all of Grantor's right, title and interest in trademarks and trademark applications, including the foregoing listed on Schedule A attached hereto (collectively, "Trademark Collateral"); and

WHEREAS, pursuant to the Security Agreement, on December 13, 2018, Grantor executed and delivered to Administrative Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("USPTO") on December 17, 2018 at Reel 6502 Frame 0263 ("Notice").


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby: (a) terminates, cancels, discharges, and releases the continuing security interest in all of Grantor's right, title and interest in the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and (b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
