RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of July 19, 2021 (this “**Release**”), by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, (“**CS**”), in its capacity as Collateral Agent under the Credit Agreement referred to below. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement.

Reference is made to (a) the Credit Agreement dated as of April 18, 2018 (as the same may be further amended, supplemented, restated, amended and restated or otherwise modified from time to time, the “**Credit Agreement**”), among EmployBridge, LLC, a California limited liability company (the “**Borrower**”), EmployBridge Holding Company, a Delaware corporation, the Lenders from time to time party thereto and CS, as Administrative Agent and as Collateral Agent, (b) the Guarantee and Collateral Agreement referred to therein, among the Borrower, the Guarantors party thereto and CS, as Collateral Agent, (c) the Notice of Grant of Security Interest in Trademarks dated as of April 18, 2018, between EB IP Holdings LLC, a Delaware limited liability company (“**EB IP Holdings**”), and CS, as Collateral Agent, and (d) the Notice of Grant of Security Interests in Trademarks dated as of April 29, 2019, between Professional Drivers of Nevada, Inc., a Georgia corporation (“**Professional Drivers of Nevada**” and, together with EB IP Holdings, the “**Grantors**”), and CS, as Collateral Agent (the documents set forth in clauses (c) and (d), the “**Trademark Security Agreements**”, and the documents set forth in clauses (b) through (d), the “**Security Documents**”).

WHEREAS, pursuant to the Security Documents, the Grantors granted to the Collateral Agent, and its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title and interest of the Grantors in, among other things, the Trademarks set forth on Schedule I hereto (the “**Trademark Collateral**”), which security interest was recorded with the United States Patent & Trademark Office on (a) April 18, 2018 at Reel/Frame 6316/0901 and (b) May 1, 2019 at Reel/Frame 6633/0475.

WHEREAS, pursuant to the Payoff Letter dated as of July 19, 2021, among the Borrower and CS, as Administrative Agent and Collateral Agent, the Collateral Agent agreed to release any and all lien and security interests it may have in the Trademark Collateral pursuant to the Security Documents.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Collateral Agent, on behalf of itself, the Secured Parties and their permitted successors and assigns, does hereby absolutely, unconditionally and irrevocably release, cancel, terminate, relinquish, discharge and reassign, in its entirety, for the benefit of the Grantors and their successors and assigns: (a) all liens and security interests created under the Guarantee and Collateral Agreement and the Trademark Security Agreements, in each case, in the Trademark Collateral, (b) all of the Collateral Agent’s and any other Secured Party’s right, title and interest in, to and under the Trademark Collateral, and (c) all liens and security interests granted to the Collateral Agent in the Trademark Collateral.


2. The Collateral Agent agrees to make filings with the United States Patent and Trademark Office and take any further actions, in each case as reasonably requested by the Grantors and at the sole expense of the Borrower, to evidence the release and termination of the security interests in the Trademark Collateral. The execution and delivery of this Release and any further documents and the performance of any actions by the Collateral Agent are made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.


3. THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.




