RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of July 21, 2021 (the “Trademark Security Release”), is made by PROSPECT CAPITAL CORPORATION in its capacity as Successor collateral agent (the “Agent”) under that certain Assignment and Assumption of 1.5 Lien Trademark Security Agreement, dated as of February 2, 2020 (the “Trademark Security Agreement”) by and among CREDIT.COM, INC. and PROGEXION IP, INC. (each individually a “Grantor” and together the “Grantors”) and the Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on February 2, 2021 at reel 7178, frame 0735, the Grantors granted to the Agent, for the benefit of the Purchasers, a Lien on and security interest in all of Grantors’ rights, titles and interests in, to and under the Trademark Collateral;

WHEREAS, the Grantors have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest and Lien on all Grantors’ rights, titles and interests in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby agree as follows:

For purposes of this Trademark Security Release, “Trademark Collateral” means the following, whether existing as of the date of the Trademark Security Agreement or thereafter created or acquired all of the Grantors’ rights, titles and interests in, to and under all the following Collateral of Grantor:

- (a) all Trademarks and applications thereof, including those listed on Schedule I attached hereto;
- (b) all goodwill associated with the foregoing; and
- (c) all proceeds of any and all of the foregoing.

The Agent, in each case, without recourse, representation or warranty of any kind whatsoever, does hereby terminate, release and discharge (a) the Liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, and (b) the entirety of its security interest in all of Grantors’ rights, titles and interests in, to and under the Trademark Collateral and any such right, title and interest of the Agent, if any, shall hereby terminate, cease and become void.

Governing Law. This Trademark Security Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws

of the State of New York without regard to conflict of laws principles thereof that would result in the application of any other law.
