**DECLARATION UNDER 37 CFR § 2.20**

I, Peter Ebright, declare that:

1. I am General Counsel of **World Yacht L.L.C.**, a Delaware limited liability company ("Current Owner"), and I am making this declaration confirming the termination of a security interest related to the guarantee by **World Yacht, Inc.**, a New York corporation ("Grantor"), of a secured loan ("Loan") given to **Circle Line-Sightseeing Yachts, Inc.**, a New York corporation ("Borrower"), by **Den Norske Bank ASA**, a Norway corporation ("Lender"), on February 26, 2002.

2. The Grantor's currently live U.S. trademark registrations identified on attached **Schedule A** ("Grantor's Marks") were secured as collateral for the Loan.

3. On May 10, 2002, a security interest notice was filed and recorded in the U.S. Patent and Trademark Office ("USPTO") at Reel No. 2507 and Frame No. 0457 in the USPTO Assignments Division to perfect and record the Lender's interest in the Grantor's Marks as collateral.

4. The Current Owner is now the current owner of the Grantor's Marks.

5. Current business, financial and legal personnel at the Current Owner have conducted a review of the Current Owner's and the Grantor's available books and records for information on the loan and its history and from the collective knowledge, interpretation and recollection of said personnel, based on and upon information and belief, it is represented that:

- The Loan has been satisfied in full by Borrower and Borrower and Grantor have been released by Lender from any and all debts and liabilities to Lender;
- Any and all obligations and relationships between Lender, on the one hand, and Borrower and Grantor, on the other hand, have been terminated and no longer exist; and
- This declaration is being provided to reflect the foregoing in the USPTO chain of title records for the Grantor's Marks.

6. The security interests in the Grantor's Marks identified on **Schedule A** granted by Grantor to Lender as collateral for the Loan to Borrower have been terminated and released due to Borrower's full payment and satisfaction of the Loan.


7. The security interests recorded at Reel No. 2507 / Frame No. 0457 in the USPTO have been and remain terminated and are of no legal effect.
