INTELLECTUAL PROPERTY ASSIGNMENT

This Assignment is made as of May 28, 2021 between,

BREATHER PRODUCTS INC., a corporation organized under the federal laws of Canada (the "Assignor")

and

INDUSTRIOUS BREATHER HOLDINGS LLC, a limited liability company organized under the laws of the State of Michigan (the "Assignee")

RECITALS

- A. The Assignor, the Assignee and Industrious Canada Staffing Ltd. entered into an asset purchase agreement as of the date hereof (the "**Purchase Agreement**"), pursuant to which the Assignor agreed to assign certain intellectual property to the Assignee.
- B. The Assignor desires to assign to the Assignee all of its right, title and interest in and to the Acquired Intellectual Property, as defined in the Purchase Agreement, and the Assignee desires to acquire the same, in each case on the terms and subject to the conditions set forth below.

FOR VALUE RECEIVED, the parties agree as follows:

- 1. **Definitions.** Unless otherwise defined herein, all capitalized terms used in this Assignment shall have the respective meanings ascribed to them in the Purchase Agreement.
- 2. **Assignment.** The Assignor does hereby sell, transfer, assign and deliver unto the Assignee, and the Assignee hereby assumes and accepts, all of the Assignor's worldwide rights, title and interests in and to all the Acquired Intellectual Property, including without limitation the patents, claims of copyright, trademarks, trade names, brand names, service marks, logos, symbols, domain names, trade dresses or designs, or representations or expressions of any thereof, or registrations or applications for registration thereof, or any other inventions, trade secrets, technical information, know-how or other proprietary rights or intellectual property and including all of the good will of the Vendor associated therewith, listed in Schedule "A" of this Agreement.
- 3. **Further Assurances.** Each Party shall from time to time promptly execute and deliver all further documents and take all further action as the other Party may reasonably request to give effect to the provisions and intent of this Agreement.
- 4. **Commissioner of Patents and Registrar of Trademarks.** The Assignor hereby authorizes and requests the Commissioner of Patents and Registrar of Trademarks, and any other applicable intellectual property office or agency, and the corresponding entities or agencies in any applicable foreign countries, to record the Assignee as the assignee and owner of the Acquired Intellectual

Property, including the patents, industrial designs, trademarks, copyrights, and applications for registration thereof listed in Exhibit "A" of this Agreement.

- 5. **Governing Law.** This Agreement is governed by, and is to be construed and interpreted in accordance with, the laws of the Province of Quebec and the laws of Canada applicable in the Province of Quebec.
- 6. **Successors and Assigns.** This Agreement enures to the benefit of and binds the Parties and their respective successors and permitted assigns.
- 7. **Severability.** If any provision of this Agreement is or becomes illegal, invalid or unenforceable in any jurisdiction, the illegality, invalidity or unenforceability of that provision will not affect:
 - (a) the legality, validity or enforceability of the remaining provisions of this Agreement; or
 - (b) the legality, validity or enforceability of that provision in any other jurisdiction.
- 8. **Counterparts.** This Agreement and other documents to be delivered pursuant to this Agreement may be executed in any number of counterparts, each of which when executed and delivered is an original but all of which taken together constitute one and the same instrument. To evidence its execution of an original counterpart of this Agreement, a Party may send a copy of its original signature on the execution page hereof to the other Party by electronic transmission and such transmissions shall constitute effective delivery of an executed copy of this Agreement to the receiving Party for all purposes.
- 9. **Choice of Language.** The Parties confirm that it is their express wish that this Agreement, as well as any other documents relating to this Agreement, including notices, schedules and authorizations, have been and shall be drawn up in the English language only. Les Parties aux présentes confirment leur volonté expresse que cette convention, de même que tous les documents s'y rattachant, y compris tous avis, annexes et autorisations s'y rattachant, soient rédigés en langue anglaise seulement.
- 10. **Miscellaneous.** This Agreement is executed and delivered pursuant to the Purchase Agreement, and is subject to, and shall be construed in accordance with, the Purchase Agreement. In the event of a conflict between the provisions of this Agreement and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement shall prevail. Nothing contained in this Agreement shall be construed to limit, expand or terminate the representations, warranties, covenants and agreements set forth in the Purchase Agreement.


5. Product Management Process Integrations with Jira and Confluence:
