Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware, as amended (the “DGCL”), Universal Spatial Holdings, Inc., a Delaware corporation (“USH”), in connection with the merger of SpatialKey, Inc., a Delaware corporation (“SpatialKey”), with and into USH (the “Merger”), hereby certifies as follows:

FIRST: The names and states of incorporation of the constituent corporations to the Merger (the “Constituent Corporations”) are:
