Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware, as amended (the “DGCL”), Insurity, Inc., a Delaware corporation (“Insurity”), in connection with the merger of Universal Spatial Holdings, Inc., a Delaware corporation (“USH”), with and into Insurity (the “Merger”), hereby certifies as follows:

FIRST: The names and states of incorporation of the constituent corporations to the Merger (the “Constituent Corporations”) are:

FOURTH: The certificate of incorporation of Insurity, as in effect immediately prior to the effectiveness of the Merger, shall remain unchanged, and shall be the certificate of incorporation of the Surviving Corporation.

FIFTH: The effective date and time of the Merger shall be 11:55 pm EST on September 30, 2020.

SIXTH: An executed copy of the Plan of Merger is on file at the office of the Surviving Corporation at 170 Huyslope Avenue, Hartford, CT 06106-2817.

SEVENTH: An executed copy of the Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any of the Constituent Corporations.
