Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware, as amended (the "DGCL"), Insurity, Inc., a Delaware corporation ("Insurity"), in connection with the merger of Valen Technologies, Inc., a Delaware corporation ("Valen"), with and into Insurity (the "Merger"), hereby certifies as follows:

FIRST: The names and states of incorporation of the constituent corporations to the Merger (the "Constituent Corporations") are:
