RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is executed as of April 30, 2021 by COMERICA BANK, a Texas banking association ("Assignor") for the benefit of VERA WHOLE HEALTH, INC., a Delaware corporation ("Assignee").

RECITALS

A. WHEREAS, pursuant to that certain Loan and Security Agreement by and between Assignor and Assignee, dated as of January 31, 2018 (as amended, restated or otherwise modified from time to time), Assignee assigned certain interests in Intellectual Property Collateral (as defined in the IP Security Agreement), including, without limitation the intellectual property described on Exhibit A attached hereto (the "Intellectual Property"), to the Assignor under that certain Intellectual Property Security Agreement dated as of February 24, 2020 (as amended, restated or otherwise modified from time to time, the "IP Security Agreement"), and recorded on April 17, 2020, at Reel 6918, Frame 0355 with the United States Patent and Trademark Office as set forth herein; and

B. WHEREAS, Assignor wishes to release all right, title and interest that Assignor may have in, to and under the Intellectual Property Collateral, including the Intellectual Property.

AGREEMENT

1. Now, therefore, Assignor agrees that it hereby terminates the IP Security Agreement, and hereby terminates, cancels, discharges and releases any and all right, title and interest (including security interests) it has in, to and under the Intellectual Property Collateral, including without limitation the Intellectual Property, and hereby reassigns to Assignee, without warranty or recourse, all right, title and interest of Assignor in, to and under the Intellectual Property Collateral.

2. Assignor shall, at the Assignee's expense, take all further actions, and provide to the Assignee, its successors, assigns and other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Assignee to more fully and effectively effectuate the purposes of this Release.

3. Assignor hereby authorizes the Assignee to record this Release with the United States Patent and Trademark Office, and any other relevant agency throughout the world.

4. This Release shall be governed by and construed in accordance with the laws of the State of California.
