**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination and Release"), dated as of July 23, 2021 is made by Bank of America N.A., as administrative agent for the Secured Parties (in such capacity, the "Administrative Agent").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of October 5, 2011 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among At Home Holding III Inc., (formerly known as GRD Holding III Corporation), a Delaware corporation, At Home Stores LLC (successor in interest to Garden Ridge, L.P.), a Delaware limited liability company, At Home Holding II Inc. (formerly known as GRD Holding II Corporation), a Delaware corporation, the other Guarantors party thereto, the Lenders from time to time party thereto and the Administrative Agent, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Intellectual Property Security Agreement Supplement, dated as of July 27, 2017 (the "Intellectual Property Security Agreement"), a lien on and security interest (collectively, the "Security Interest") was granted by the Grantors to the Administrative Agent in certain collateral, including the Additional Collateral;

WHEREAS, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on July 28, 2017 at Reel/Frame 06116/0182.

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Additional Collateral, including those trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Intellectual Property Security Agreement or the Credit Agreement, as applicable.
2. Release of Security Interest. The Administrative Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Additional Collateral, and any right, title or interest of the Administrative Agent in such Additional Collateral shall hereby cease and become void.
3. Recordation. The Administrative Agent authorizes the Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Grantor's expense.
