#### RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of July 23, 2021, is made by CITIBANK, N.A., as collateral agent for the Secured Parties (the "Collateral Agent") under that certain Second Amended and Restated Credit and Guaranty Agreement, dated as of March 10, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Credit Agreement"), in favor of APCO Worldwide LLC, a Delaware limited liability company, APCO Worldwide Holdings Inc. and Ellipse Strategy Group Inc. (each, individually, a "Grantor" and, collectively, the "Grantors").

#### WITNESSETH:

WHEREAS, pursuant to that certain Amended and Restated Pledge and Security Agreement, dated as of March 10, 2020 (the "Security Agreement"), made by the Grantors in favor of the Collateral Agent, the Grantors granted a security interest to the Grantee in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered an Intellectual Property Security Agreement, dated as of March 10, 2020 (the "IP Security Agreement"), for recordation with the United States Patent and Trademark Office and the United States Copyright Office;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office and with the United States Copyright Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the IP Security Agreement, as applicable.
- 2. <u>Release</u>. The Collateral Agent, without any representation or warranty of any kind, hereby releases, discharges, terminates, and cancels all of its security interest in and to all of Grantor's right, title and interest in, to and under the following:
  - a) Copyrights, including, without limitation, the registrations and applications referred to in Schedule I attached hereto;
  - b) Patents;
  - c) Trademarks, including, without limitation, the registrations and applications referred to in Schedule II attached hereto;
  - d) Trade Secrets; and
  - e) all licenses or agreements, whether written or oral, providing for the grant by or to any Grantor of: (i) any right to use any Trademark or Trade Secret, (ii) any right to manufacture, use, import, export, distribute, offer for sale or sell any invention covered in whole or in part by a Patent, and (iii) any right under any Copyright including, without limitation, (A) the grant of rights to manufacture, distribute, exploit and sell materials derived from any Copyright including, without limitation, any of the foregoing identified

in Schedule I attached hereto, (B) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations of any of the foregoing, (C) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), (D) all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto, and (E) any and all proceeds of the foregoing ((a) through (e), collectively, the "Intellectual Property Collateral").

If and to the extent that the Collateral Agent has acquired any right, title, or interest in and to the Intellectual Property Collateral of the Grantors under the IP Security Agreement or the Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, reconveys, and re-assigns such right, title or interest to the Grantors. The Collateral Agent authorizes and requests that this Release be recorded at the United States Patent and Trademark Office or the United States Copyright Office, as applicable.

- 3. <u>Termination</u>. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the IP Security Agreement.
- 4. <u>Further Assurances</u>. The Collateral Agent agrees to take all further actions, and provide to the Grantors all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, to effectively effectuate the purposes of this Release.
- 5. Counterparts. This Release may be executed in any number of counterparts, all of which taken together shall constitute one agreement, and any of the parties hereto may execute this Release by signing any such counterpart. The Grantors acknowledge that delivery of an executed counterpart of a signature page of this Release by fax or electronic mail transmission shall be effective as delivery of a manually executed counterpart of this Release. The words "execution," "execute", "signed," "signature," and words of like import in or related to any document to be signed in connection with this Release (including any amendments and other notices, waivers and consents) shall be deemed to include electronic signatures or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.
- 6. <u>Severability</u>. Any provision in this Release that is held to be inoperative, unenforceable or invalid in any jurisdiction shall, as to that jurisdiction, be inoperative, unenforceable or invalid without affecting the remaining provisions in that jurisdiction or the operation, enforceability or validity of that provision in any other jurisdiction, and to this end the provisions of this Release are declared to be severable.
- 7. <u>Governing Law</u>. This Release and any right, remedy, obligation, claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Release shall be governed by, and construed in accordance with, the law of the State of New York.


