RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of July 7, 2021 (this "Release"), is made by BANK OF AMERICA, N.A., as administrative agent (in such capacity, the "Administrative Agent") for the Secured Parties, in favor of UNITED TALENT AGENCY, LLC, a Delaware limited liability company (the "Borrower") and DBA MEDIA LLC, a New York limited liability company (the "Grantor" and together with the Borrower, the "Grantors"). Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

WITNESSETH

WHEREAS, Borrower, the Administrative Agent, and the other parties party thereto from time to time, are parties to that certain Amended and Restated Credit and Guaranty Agreement dated as of April 16, 2018 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Amended and Restated Pledge and Security Agreement, dated as of April 16, 2018 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors executed the Trademark Security Agreement, dated as of January 13, 2021 (the "Agreement") and recorded with the U.S. Patent and Trademark Office on January 13, 2021 at Reel/Frame Nos. 7200/0987 and 7161/0740, pursuant to which the Grantors granted to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all right, title and interest in or to the Trademark Collateral (as defined in the Agreement).


WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in all right, title and interest in or to the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES FULLY, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged fully, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Agreement. The Administrative Agent authorizes the recordation of this Release with the U.S. Patent and Trademark Office by the Grantors or their designees.
