This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 23, 2021 ("Release"), is made by FIDUS INVESTMENT CORPORATION, a Maryland corporation, as Agent ("Grantee") in favor of REVENTION, LLC., a Delaware limited liability company ("Grantor").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

SECTION 2. Termination and Release. Grantee, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of its right, title and interest in and to the Trademarks and the use thereof, together with all products and proceeds thereof and the goodwill of the businesses symbolized by the Trademarks, granted pursuant to the Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.
