INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (“**IP Assignment**”), dated as of June 28, 2021 (the “**Effective Date**”) is made by and between Teleflex Incorporated, a Delaware corporation (“**Teleflex**”), Teleflex Medical Incorporated, a California corporation (“**TMI**”) (each of Teleflex and TMI individually, and collectively, the “**Seller**”) and Medline Industries, Inc., an Illinois corporation (“**Buyer**”), the purchaser of certain assets of Seller pursuant to an Asset Purchase Agreement between Buyer and Seller, dated as of May 15, 2021 (as amended, the “**Asset Purchase Agreement**”). The Seller and the Buyer may each be referred to herein individually as a “**Party**” or collectively as “**Parties**.”

WHEREAS, under the terms of the Asset Purchase Agreement, Seller has conveyed, transferred and assigned to Buyer, among other assets, certain intellectual property of Seller, and has agreed to execute and deliver this IP Assignment;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably conveys, transfers and assigns to Buyer, and Buyer hereby accepts, all of Seller's right, title and interest in and to the following (the “**Assigned IP**”):

(a) the patents and patent applications set forth on Schedule A hereto (collectively, the “**Listed Patents**”), together with (1) patents or patent applications for which any of the Listed Patents forms a basis for priority, (2) reissues, reexaminations, extensions, continuations, continuations in part, continuing prosecution applications, requests for continuing examinations, divisionals, certificates of invention, utility models, and registrations of any item in any of the foregoing categories; (3) any items in any of the foregoing categories, whether or not expressly listed as Listed Patents and whether or not claims in any of the foregoing have been rejected, withdrawn, cancelled, or the like (collectively, the “**Patents**”);

(b) all subject matter, and each invention, claimed in each of the Patents and all embodiments of such subject matter and inventions (collectively, the “**Inventions**”);

(c) all rights of any kind whatsoever of Seller accruing under any of the Patents and Inventions provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(d) the trademark applications and registered trademarks, common law trademark and design rights, domain names, and any associated trademark and design rights set forth on Schedule B hereto (collectively, the “**Listed Trademarks and Domains**”), together with all goodwill of the business connected with the use thereof or symbolized by the Listed Trademarks and Domains (collectively, the “**Trademarks and Domains**”); Without limitation to the generality of the foregoing, with respect to United States intent- to-use trademark applications included in the Trademarks (“**ITU Applications**”), the assignment granted under the foregoing Assignment

provision accompanies the transfer of Assignor's business or portion of the business to which such ITU Applications pertain, and that business is ongoing and existing, or the transfer of such ITU Applications shall not be effective until the expiration of any period during which the assignment thereof would impair, under applicable federal law, the registrability of such ITU Applications or the validity or enforceability of registrations issuing from such ITU Applications.

(e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(f) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Seller hereby authorizes the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by Buyer. Following the date hereof, Seller shall take such steps and actions, and provide such cooperation and assistance to Buyer and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of or transfer (in the case of domain names) the Assigned IP to Buyer, or any assignee or successor thereto. Seller also authorizes and requests the attorney or agent of record to insert on this IP Assignment any further identification that may be necessary or desirable in order to comply with the rules of the respective patent office or governmental agency in each jurisdiction for recordation or other official recognition.

3. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this IP Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Buyer with respect to the Assigned IP. The representations, warranties, covenants, agreements, indemnities and limitations of liability contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.


4. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.

5. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


6. Governing Law; Dispute Resolution. This IP Assignment and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this IP Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction). Any dispute arising out of or in connection with this Agreement, including any disputes regarding the existence, validity or termination thereof, shall be subject to the exclusive jurisdiction of the Delaware Court of Chancery or any federal court located in the State of Delaware, and Seller and Buyer each hereby waive the right to assert the lack of personal or subject matter jurisdiction or improper venue in connection with any such suit, action or other proceeding. Each party hereto irrevocably waives the right to a jury trial with respect to any action related to this IP Assignment.
