**TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS)**

**THIS TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS)** (this "Termination"), is dated as of July 27, 2021, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **CYBERGRANTS, LLC**, a Massachusetts limited liability company (the "Grantor").

WHEREAS, the Grantor has adopted, used and is using trademarks listed opposite the Grantor's name on the Exhibit A, annexed hereto as part hereof, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, pursuant to that certain Security Agreement (Trademarks) dated as of May 29, 2015, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest in all right, title and interest was granted by the Grantor to Grantee in and to its general intangibles, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on June 1, 2015, at Reel/Frame 5527/0115;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in and to its general intangibles, including, without limitation, the Trademarks listed on Exhibit A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in all right, title and interest to the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.
