**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “Release”), dated as of July 27, 2021, is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent (the “Administrative Agent”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain (i) Credit Agreement (the “Original Credit Agreement”), dated as of March 31, 2010, among Cecil I. Walker Machinery Co., a West Virginia corporation (due to merger, now known as Boyd Company) (“Cecil I. Walker Machinery Co.”), the Lenders party thereto and Administrative Agent, and (ii) Amended and Restated Credit Agreement (the “Amended and Restated Credit Agreement”), and with the Original Credit Agreement, the “Credit Agreement”), dated as of January 17, 2017, among Cecil I. Walker Machinery Co., Whayne Supply Company, a Kentucky corporation (now known as Boyd Company) (“Whayne Supply Company”, and with Cecil I. Walker Machinery Co. the “Grantors”), the Lenders party thereto and Administrative Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Borrowers;

WHEREAS, the Grantors entered into those certain (i) Pledge and Security Agreement (the “Original Pledge and Security Agreement”), dated as of March 31, 2010, and (ii) Amended and Restated Pledge and Security Agreement (the “Amended and Restated Pledge and Security Agreement”), and with the Pledge and Security Agreement, the “Security Agreement”), dated as of January 17, 2017, in favor of the Administrative Agent;

WHEREAS, in connection with the Credit Agreement, Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the “IP Security Agreements”), the Grantors granted security interests in certain intellectual property owned by the Grantors, including those listed on Annex I attached hereto (the “IP Collateral”); and

WHEREAS, the IP Security Agreements were recorded in the United States Patent and Trademark Office, on the dates and on the reels/frames or volume/document no., as applicable, set forth on Annex I attached hereto.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the IP Collateral, whether granted pursuant to the Security Agreement, the IP Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the IP Collateral to the relevant Grantor.

The Administrative Agent agrees, at the Grantors’ sole expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent’s security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
