THE DELAWARE LIMITED LIABILITY COMPANY ACT**

This Certificate of Conversion, dated as of February 10, 2021 is being duly executed and filed by Apria Healthcare Group Inc., a Delaware corporation (the "Corporation"), to convert the Corporation to Apria Healthcare Group LLC, a Delaware limited liability company (the "LLC"), under Section 266 of the General Corporation Law of the State of Delaware (8 Del. C. § 101, et seq.) and Section 18-214 of the Delaware Limited Liability Company Act (6 Del. C. § 18-101, et seq.).

1. The Corporation filed its original certificate of incorporation with the Secretary of State of the State of Delaware and was first incorporated on June 17, 1991 as a Delaware corporation. On January 16, 2014, the Corporation converted to a Delaware limited liability company under the name "Apria Healthcare Group LLC" and, thereafter, on January 16, 2014 converted back to a Delaware corporation under the name "Apria Healthcare Group Inc." by filing a certificate of conversion and a certificate of incorporation with the Secretary of State of the State of Delaware.

2. The name and type of entity of the Corporation immediately prior to filing this Certificate of Conversion is Apria Healthcare Group Inc., a Delaware corporation.

3. The name of the LLC as set forth in the Certificate of Formation filed in accordance with Section 18-214(b) of the Delaware Limited Liability Company Act is Apria Healthcare Group LLC.

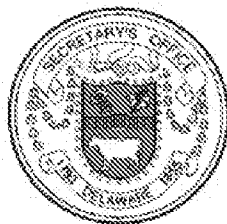

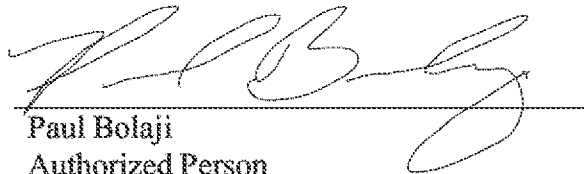
