**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of July 28, 2021 (the “Effective Date”), is made by GOLUB CAPITAL MARKETS LLC, as agent for the Secured Parties (in such capacity, the “Administrative Agent”) in favor of ROUGH COUNTRY, LLC, a Delaware limited liability company (“Grantor”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain First Lien Security Agreement among the Grantor, the Administrative Agent, and certain other parties, dated as of May 25, 2017 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantor executed and delivered that certain Trademark Security Agreement, dated as of May 25, 2017 (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office (“USPTO”) on May 25, 2017 at Reel/Frame 6068/0628;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor unconditionally granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in, lien and mortgage in and to, right of setoff against and collateral assignment of (the “Security Interest”) all of the Grantor’s right, title and interest in and to the following Collateral, whether then owned or thereafter acquired or arising, but in any event excluding any Excluded Property: (a) all of its Trademarks and Trademark Licenses to which it is a party including those referred to on Schedule I; (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and (c) all rights, priorities and privileges related thereto and all rights to sue at law or in equity for any infringement, dilution or other violation or impairment of any of the foregoing, and including the right to receive all products and all proceeds (as that term is defined in the Code) of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark License (collectively, the “Trademark Collateral”); and

WHEREAS, the Administrative Agent and the Grantor acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, hereby (a) terminates and cancels the Trademark Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (c) re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral, in each case without recourse to the Administrative Agent and without representation or warranty of any kind.

The Grantor, or any successor to the Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral), is hereby authorized to record this Release in the USPTO.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be executed and delivered by its duly authorized representative as of the Effective Date.
