**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 22, 2021 (“Release”), is made by Capital One, National Association, on behalf of itself and the other Secured Parties (“Lender”) in favor of Cognosante Holdings, LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Guaranty and Collateral Agreement dated as of October 29, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”) by and among the Grantor and Lender, and the Trademark Security Agreement dated as of October 29, 2020 by and among the Grantor and Lender (“Trademark Security Agreement”), Grantor granted to Lender a Lien on and security interest in all of its right, title and interest in, to, and under the Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on November 20, 2020 at Reel 7112 Frame 0834.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to, and the right to set off against, Grantor’s right, title, and interest in, to, and under all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement or Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
