## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 24, 2021 (the "Release Date"), by ELSLACK OOD (the "Lender"), for the benefit of Tavistock Restaurants LLC (the "Grantor").

WHEREAS, the Grantor has entered into (i) that certain Pledge and Security Agreement, dated as of March 25, 2020, in favor of the Lender, and (ii) that certain Trademark Security Agreement, dated as of March 25, 2020 in favor of the Lender (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor pledged and granted to the Lender a lien on and security interest in and to all of its right, title and interest in, to and under all of the following Collateral of the Grantor, whether then existing or thereafter arising or acquired from time to time (collectively, the "Trademark Collateral"): (i) all of the Grantor's Trademarks and all Trademark Licenses providing for the grant by or to the Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule I hereto, (ii) all renewals and extensions of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark, and (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, dilution, violation or other impairment thereof;

WHEREAS, the Lender has filed with the United States Patent and Trademark Office (the "USPTO") notices of security interests in the Trademark Collateral, the Trademark Security Agreement was recorded by the USPTO on March 26, 2020 at Reel 6900, Frame 0511; and

WHEREAS, the Grantor requests the Lender to release its security interest in that certain Trademark Collateral set forth on Schedule I hereto in order to facilitate the Grantor's efforts to resolve its outstanding liabilities, and the Lender is willing to release its security interest as set forth herein.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Lender hereby, without any representation and warranty and without any recourse (a) terminates the Liens and security interests created under the Trademark Security Agreement in the Trademark Collateral set forth on Schedule I hereto, (b) releases its security interest in the Trademark Collateral set forth on Schedule I hereto, and (c) discharges any and all rights, title and interest it has in and the security interest granted to the Lender in the Trademark Collateral set forth on Schedule I hereto.

2. Recordation of Release. The Lender understands and agrees that this Release may be recorded by or for the Grantor with the USPTO.

3. Further Actions. The Lender further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release; provided, that all such documents are to be prepared by counsel to the Grantor and the cost and expense of such documents and actions shall be borne solely by the Grantor.



Except as expressly set forth in this Release, no other changes or modifications to the Trademark Security Agreement are intended or implied by this Release and in all other respects the Trademark Security Agreement shall remain in full force and effect as of the Release Date.

5. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Trademark Security Agreement.
