## CONFIRMATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

**WHEREAS Righteous Gelato Ltd.** (the “**Obligor**”), a corporation incorporated under the laws of the Province of Alberta with offices at Suite 110, 221 19 Street SE, Calgary, AB T2E 7M2, is the owner of the patents, patent applications, trademark registrations, and trademark applications listed in Exhibit 1 (collectively, the “**IP Assets**”); and
