RELEASE OF SECURITY INTERESTS IN TRADEMARKS

The Secured Party authorizes and requests the Director of Patents and Trademarks of the United States of America to record this Release and agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as Grantors may reasonably request in order to perfect, confirm or evidence such release. Secured Party hereby represents and warrants that it has full authority to execute and deliver this Release. This Release shall be governed by and construed in accordance with the law of the State of New York. This Release shall be binding upon Secured Party's representatives, successors, assigns and transferees.

If and to the extent that Secured Party has acquired any right, title or interest in or to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the applicable Grantor, along with any goodwill in the Trademarks that Secured Party may have acquired.
