TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS ("**Termination**") is made and effective as of this 30th day of June, 2021 and made by POPLAR HEALTHCARE, PLLC ("**Poplar Healthcare**"), a Tennessee professional limited liability company, pursuant to Order of the United States Bankruptcy Court for the District of Delaware in case styled, In re Bostwick Laboratories, Inc., et al., Case No. 17-10570 (BLS).

WHEREAS, on or about September 19 2012, security interests (the "**Security Interests**") were filed of record against certain trademarks which were then the property of Bostwick Laboratories, Inc. as more particularly described on Schedule 1 attached hereto (the "**Trademarks**") by General Electric Capital Corporation.

WHEREAS, by Assignment of Security Interest filed on or about November 30, 2015, the previously filed the Security Interest of record was assigned by General Electric Capital Corporation to General Electric Capital Corporation, As Agent.

WHEREAS, on March 15, 2017, Bostwick Laboratories, Inc. ("**Bostwick**") filed a voluntary case under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware as Case No. 17-10570 (BLS) (the "**Bankruptcy Case**").

WHEREAS, in the Bankruptcy Case, Bostwick filed a motion seeking an order approving the sale of substantially all of its assets free and clear of all Claims, Liens, Rights, Interests and Encumbrances pursuant to Section 363 of the Bankruptcy Code pursuant to the terms and conditions of that certain Amended Stalking Horse Asset Purchase Agreement dated March 20, 2017 between Poplar Healthcare, as purchaser and Bostwick, as seller, a copy of which is attached as Exhibit A hereto (the "**APA**").

WHEREAS, an ORDER (I) AUTHORIZING AND APPROVING THE SALE OF SUBSTANTIALLY ALL OF THE DEBTORS' ASSETS FREE AND CLEAR OF ALL CLAIMS, LIENS, RIGHTS, INTEREST AND ENCUMBRANCES, (II) APPROVING THE ASSET PURCHASE AGREEMENT AND (III) AUTHORIZING THE DEBTORS TO ASSUME AND ASSIGN CERTAIN EXECUTORY CONTRACTS AND UNEXPIRED LEASES was entered by the Bankruptcy Court on April 28, 2017 a copy of which is attached as Exhibit B hereto (the "**Sale Order**").

WHEREAS, pursuant to Section 2.1(b)(vi) of the APA as approved by the Sale Order, Poplar Healthcare purchased all of Bostwick's right, title and interest in and to the intellectual property used in the conduct of the business of Bostwick including all trade names, trademarks, trademark registrations, trademark application, service marks, service mark registrations, service mark applications, copyrights, copyright registrations, copyright applications and patent rights (collectively the "**Intellectual Property**") as a part of the Purchased Assets as defined in the APA.

WHEREAS, in accordance with ordering Paragraph 4 of the Sale Order, Poplar Healthcare purchase the Purchased Assets, including all of the Intellectual Property and Trademarks of Bostwick free and clear of liens and encumbrances pursuant to Sections 105(a) and 363 of the Bankruptcy Code.

WHEREAS, in accordance with ordering Paragraph 5 of the Sale Order, "All filing agents, filing officers, title agents, title companies, recorders of mortgages, recorders of deeds, registrars of deeds, administrative agencies, governmental departments, secretaries of state, federal, state, and local officials, and all other persons and entities who may be required by operation of law, the duties of their office, or contract, to accept, file, register or otherwise record or release any documents or instruments, or who may be required to report or insure any title or state of title in or to any of the Assets are hereby authorized to do so in accordance with this Order. Each and every federal, state, and local governmental agency or department or office is hereby authorized to accept this Order and any and all documents and instruments necessary and appropriate to consummate the sale contemplated by the APA and to cancel, terminate and release the Encumbrances."

WHEREAS, in accordance with ordering Paragraph 6 of the Sale Order, "If any person or entity that has filed a financing statement, deed of mortgage, or other deeds, documents or agreements evidencing an Encumbrance on a Purchased Asset shall not have delivered, in proper form for filing, termination statements, deeds of cancelation of mortgage, instruments of satisfaction, cancelation, termination, releases, and other deeds and documents to the Debtors before the Closing, then the Debtors and the Purchaser shall be and hereby are authorized to execute such termination statements, deeds of cancelation of mortgage, instruments of satisfaction, cancelation, termination, releases, and other deeds and documents on behalf of such person or entity and to file the same with any appropriate registry or public filing office. Notwithstanding the foregoing, the provisions of this Order authorizing the sale and assignment of the Purchased Assets free and clear of Encumbrances (subject to Permitted Encumbrances) shall be self-executing. "

WHEREAS, a search of the records of this office reflects that General Electric Capital Corporation, As Agent has failed to release the Security Interests previously place of record and in accordance with the terms of the Sale Order, Poplar Healthcare, as Purchaser of the Purchased Assets including, but not limited to the Trademarks is therefore authorized to file this termination of the Security Interests placed of record against Bostwick.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Poplar Healthcare hereby states as follows:

1. Termination of Security Interests. Poplar Healthcare, in accordance with the terms of the Sale Order, hereby terminates, releases, and discharges any and all Security Interests of record against Bostwick, including but not limited to those more particularly described on **Schedule 1**

(a) in and to any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule 2 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (the "**Trademarks**");

(b) all rights of any kind whatsoever of Bostwick or the holder of the Security Interest accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; and

(c) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Governing Law. This Termination and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Termination and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Tennessee, without giving effect to any choice or conflict of law provision or rule (whether of the State of Tennessee or any other jurisdiction).

3. Request. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the termination and release hereby made.
