**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of July 14, 2021 (the “Effective Date”), is made by Jefferies Finance LLC, in its capacity as administrative agent and collateral agent (the “Agent”), in favor of The Hillman Group, Inc., Big Time Products, LLC, and NB Products LLC (as successor to Rooster Products International, Inc., Apollo Marketing, LLC, and Big Time Décor, LLC) (each a “Grantor” and collectively, the “Grantors”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the applicable Trademark Security Agreement.

WHEREAS, pursuant to that certain Security Agreement, dated as of May 31, 2018, by and among the Barclays Bank PLC (the “Original Agent”), the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Original Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, The Hillman Group, Inc. executed and delivered that certain Term Trademark Security Agreement, dated as of May 31, 2018, which was recorded with the United States Patent and Trademark Office (“USPTO”) on June 4, 2018 at Reel/Frame 6393/0295 (“2018 Trademark Security Agreement”);

WHEREAS, pursuant to a Resignation, Consent and Appointment Agreement, dated as of October 1, 2018, the Agent succeeded to the Original Agent, and the security interest granted pursuant to the Security Agreement and the 2018 Trademark Security Agreement was transferred to the Agent, notice of which was recorded in the USPTO on October 3, 2018 at Reel/Frame 6448/0772;

WHEREAS, pursuant to the Security Agreement, (i) Big Time Products, LLC, Rooster Products International, Inc., Apollo Marketing, LLC, and Big Time Décor, LLC executed and delivered that certain Term Trademark Security Agreement, dated as of January 31, 2019, which was recorded with the USPTO the on February 1, 2019 at Reel/Frame 6547/0225 (the “January 2019 Trademark Security Agreement”), (ii) The Hillman Group, Inc. executed and delivered that certain Term Trademark Security Agreement Supplement, dated as of March 29, 2019, which was recorded with the USPTO on April 1, 2019 at Reel/Frame 6605/0787 (the “March 2019 Trademark Security Agreement”), and (iii) The Hillman Group, Inc. executed and delivered that certain Term Trademark Security Agreement Supplement, dated as of October 16, 2019, which was recorded with the USPTO on October 18, 2019 at Reel/Frame 6774/0362 (the “Hillman October 2019 Trademark Security Agreement”); and (iv) Rooster Products International, Inc. and Big Time Products, LLC executed and delivered that certain Term Trademark Security Agreement Supplement, dated as of October 16, 2019, which was recorded with the USPTO on October 18, 2019 at Reel/Frame 6774/0354 (the “Big Time October 2019 Trademark Security Agreement”);

WHEREAS, certain of the Grantors executed and delivered that certain Trademark Security Agreement, dated as of May 31, 2018 (as modified by that certain Notice of Succession of Agency, dated as of October 1, 2018 (“Notice of Succession in Agency”) and as may be further amended, amended and restated, or otherwise modified from time to time, the “2018 Trademark Security Agreement”), that certain Trademark Security Agreement, dated as of January 31, 2019 (as amended, amended and restated, or otherwise modified from time to time, the “January 2019 Trademark Security Agreement”), that certain Trademark Security Agreement Supplement, dated as of March 29, 2019 (as amended, amended and restated, or otherwise modified from time to time, the “March 2019 Trademark Security Agreement”), that certain Trademark Security Agreement Supplement, dated as of October 16, 2019 (as amended, amended and restated, or otherwise modified from time to time, the “Hillman October 2019 Trademark

Security Agreement” and together with the 2018 Trademark Security Agreement, the January 2019 Trademark Security Agreement, the March 2019 Trademark Security Agreement and the Hillman October 2019 Trademark Security Agreement, the “Trademark Security Agreements”),

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreements, each applicable Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Agent, its successors and permitted assigns, on behalf of and for the benefit of the Secured Parties, a continuing security interest (the “Security Interests”) in all of its right, title, and interest in, to and under (i) all trademarks (including service marks), common law marks, trade names, trade dress, domain names and logos, slogans and other indicia of origin under the laws of any jurisdiction in the world, and the registrations and applications for registration thereof (including but not limited to the registrations and applications listed on Schedule I hereto); and the goodwill of the business connected with the use of and symbolized by the foregoing, (ii) all renewals of the foregoing, (iii) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past, present and future infringements or dilutions thereof, (iv) all rights to sue for past, present, and future infringements or dilutions of any of the foregoing, including the right to settle suits involving claims and demands for royalties owing, and (v) all rights corresponding to any of the foregoing, in each case, excluding any Excluded Assets. (the “Trademark Collateral”);

WHEREAS, the Agent and the Grantors acknowledge that the requirements for releasing the Security Interests in the Trademark Collateral have been met.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, without representation or warranty of any kind, hereby (i) terminates and cancels the Trademark Security Agreements, and (ii) releases, discharges, terminates and cancels all of its Security Interests in and to the Trademark Collateral arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral pursuant to the Security Agreement or any of the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor) is hereby authorized to record this Release with the USPTO.

This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
