**Release of Security Interest in Trademarks**

This Release of Security Interest in Trademarks, dated as of **July 28, 2021** (the “Release”), is made by **Owl Rock Capital Corporation**, as collateral agent (in such capacity, the “Agent”) in favor of **Trader TN Holdings, LLC**, a **Delaware Limited Liability Company** (the “Grantor”).

WHEREAS, by (i) that certain Pledge and Security Agreement, dated as of **June 15, 2017** in favor of Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related Intellectual Property Security Agreement, dated as of **March 12, 2020** in favor of Agent (as amended, restated, or modified from time to time, the “IP Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement, as applicable), which IP Security Agreement was recorded with the United States Patent and Trademark Office on **March 20, 2020** at Reel **006896** Frame **0950**, the Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor’s right, title and interest in, to and under the Collateral (as defined in the IP Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantor desires Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantor (as defined in the IP Security Agreement), including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantor (as defined in the IP Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Collateral.


The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
