**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Termination”), dated as of July 1, 2021, is executed by AB PRIVATE CREDIT INVESTORS LLC, as administrative agent (“Administrative Agent”), in favor of CONTEGIX, LLC, a Missouri limited liability company (“Grantor”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of June 12, 2017 (“Security Agreement”), executed by Grantor in favor of Administrative Agent, Grantor granted to Administrative Agent a security interest in the IP Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on June 12, 2017 at Reel 6081 and Frame 0911 to evidence the security interest granted under the Security Agreement.

C. Administrative Agent agrees to terminate and release its security interest in the IP Collateral specified below and to file this Termination with respect to such release of its security interest as herein provided.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates and releases all of Administrative Agent’s right, title and interest in pursuant to the Security Agreement, to and under the following (collectively, the “IP Collateral”):

(i) patents and patent applications, including, without limitation those set forth in Schedule 1, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (collectively, the “Patents”);

(ii) trademark registrations and applications, including, without limitation, those set forth in Schedule 2, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (collectively, the “Trademarks”);

(iii) copyrights, copyright registrations, and copyright applications, including, without limitation, those set forth in Schedule 3, and all extensions and renewals thereof (collectively, the “Copyrights”);

(iv) all rights of any kind whatsoever of Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(v) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(vi) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages; provided that nothing in this Termination shall constitute an assignment of an "intent to use" application of a trademark, to the extent such assignment would render the application void.


(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.
