This Trademark Assignment Declaration ("Declaration") is entered into on 21 November 2019, by and between

Kaltenbach & Voigt GmbH ("Assignor"), incorporated under the laws of Germany, with its registered office in Biberach an der RIB, registered with the commercial register of the Local Court of Ulm under HRB 641815

and

KaVo Dental GmbH ("Assignee"), incorporated under the laws of Germany, with its registered office in Biberach an der RIB, registered with the commercial register of the Local Court of Ulm under HRB 641816.

Assignor and Assignee are hereinafter referred together as the "Parties".

## 1. DEFINITIONS

"Assignment Agreement" means the "Spin-off and Acquisition Agreement" signed by the parties which became effective upon its registration in the commercial register on 9 July 2019.

"Assigned Trademarks" means all trademark registrations and applications registered or filed by the Assignor listed in Schedule 1 regardless of the address in trademark registers.

## 2. ASSIGNOR'S REPRESENTATIONS, WARRANTIES AND CONFIRMATIONS

Assignor hereby represents and warrants

- a) that it owned all rights, title and interest in the Assigned Trademarks,
- b) that it had the legal right and authority to execute the Assignment Agreement, and to validly assign the entire interest in the Assigned Trademarks to Assignee, and
- c) that it had not executed any other agreement that would conflict with the terms of the Assignment Agreement,

at the time when the Assignment Agreement was signed by Assignor and Assignee.

Assignor hereby confirms

- a) that Assignor has assigned to Assignee the full and exclusive rights, including all rights of priority, titles and interests in, belonging to and arising from the Assigned Trademarks, for all countries, together with the goodwill attaching to the said trademarks,
- b) to agree to the recordal of the transfer of rights to Assignee in all registers, and
- c) to agree executing any further declarations and documents, and to take any further actions, necessary to support Assignee to record the transfer of Assigned Trademarks and to utilize Assigned Trademarks by other means.

If the trademarks assignment requires execution of additional bilateral or unilateral documents under the relevant applicable national law in any of the effective states, the

Parties shall execute such documents as addendum to the Declaration in a time-efficient manner.



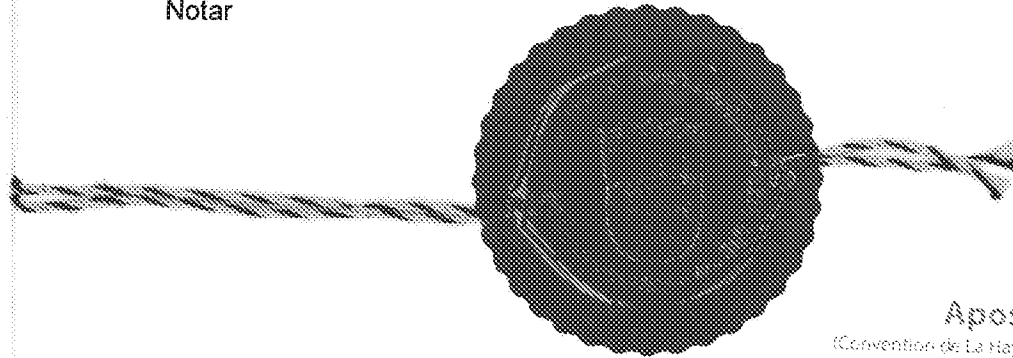
