**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made as of July 26, 2021, by Stonegate Asset Company II, LLC, a Delaware limited liability company ("Lender") in favor of Zevia LLC, a Delaware limited liability company ("Borrower").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated April 15, 2019, by and among Borrower and Lender (the "Security Agreement"), recorded on April 16, 2019, at Reel 6620, Frame 0126, United States Patent and Trademark Office, Borrower granted a security interest in certain trademarks in favor of Lender to secure certain debt owing from Borrower to Lender;


