TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (“the Agreement”) is made and effective as of April 28, 2021, by and between **CYBERINC CORPORATION**, a Delaware corporation (“Assignor”), to **AURIONPRO FINTECH INC.**, a Delaware corporation (“Assignee”).

WHEREAS, Assignor has adopted, owns, uses or intends to use the respective registered trademarks set forth in Attachment 1 of this Agreement (collectively, the “Marks”); and

WHEREAS, Assignor desires to convey, transfer, assign, deliver, and contribute to Assignee all of Assignor’s right, title, and interest in and to the Marks and associated goodwill, and Assignee desires to accept all of Assignor’s right, title and interest in and to the Marks and the associated goodwill.

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) now paid by the Assignee to the Assignor, and other good and valuable consideration, the receipt of which is hereby acknowledged:

1. Assignor hereby sells, transfers, conveys, assigns, and delivers to Assignee and its successors and assigns all right, title and interest in and to the Marks, including all common law rights in same, in the United States of America and all other countries and jurisdictions of the world, together with all goodwill associated with the Marks and/or of the business symbolized by or related to the Marks, and all proprietary and intellectual property rights subsisting in the Marks, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors and assigns to the end of the term or terms for which the Marks are granted or reissued or extended as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.

2. Assignor hereby assigns to Assignee all income, royalties, damages and payments now or hereafter due or payable with respect to the Marks, including in and under all causes of action (in law or in equity), claims and rights to damages or profits, due or accrued, arising out of past infringement of the Marks, or injury to the goodwill associated with the Marks, as well as the rights to sue for and recover the Marks in Assignee’s own name.

3. This Agreement is binding upon and inures to the benefit of the parties hereto and their respective successors and assigns. This Agreement and the rights and obligations of the Parties hereunder shall be governed by and construed in accordance with the laws of the State of California.

4. Assignor agrees to execute and deliver such other documents and to take all such other actions which the Assignee, its successors and assigns may commercially reasonably request to effect the terms of this Agreement and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens and other documentation as may be commercially reasonably required to effect the terms of this Agreement.

5. Assignor shall, at the cost and expense of Assignee, reasonably cooperate in any actions necessary for Assignee to prosecute, renew or register its rights, title and interests in and


to the Marks, including United States and foreign registrations, and reasonably cooperate in any actions brought to enforce the rights accompanying this Agreement against third parties.

6. Any rule of construction to the effect that ambiguities are to be resolved against the drafting party will not be applied in the construction or interpretation of this Agreement. The words “include”, “including” and variations thereof will be deemed to be followed by the words “without limitation”. The use of “or” will not be deemed to be exclusive. This Agreement may be executed in counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement.





