RELEASE OF TRADEMARK SECURITY INTERESTS

(ii) All proceeds of the foregoing, including without limitation any claim by Grantor against third parties for damages by reason of past, present or future infringement or dilution of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.

The Grantee hereby represents and warrants to the Grantor that it has not, directly or indirectly, by operation of law or otherwise, assigned, transferred or conveyed any of its rights or obligations with respect to the Agreement or any trademark, trademark registration, or trademark application listed on Schedule A hereto.
