**RELEASE AND TERMINATION
OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS, dated as of July 30, 2021 (this “Release”), is made by MGG California LLC, acting in its capacity as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”) under that certain Assignment for Security - Trademarks, dated as of December 4, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”), by and between BUYERZONE.COM LLC (the “Assignor”) and the Collateral Agent. Capitalized terms used herein without definition are used as defined in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on December 11, 2020 at reel 7150/frame 0839, the Assignor granted to the Collateral Agent a continuing security interest in all of the Assignor’s right, title and interest in, to and under its owned or thereafter acquired Trademarks, including those Trademarks set forth on the attached Schedule A;

WHEREAS, pursuant to that certain Payoff Letter, dated as of July 30, 2021, by and among the Assignor, the other signatories party thereto and the Collateral Agent, the Assignor has requested that the Collateral Agent, and the Collateral Agent has agreed to, (a) release any and all security interests it may have in the Collateral pursuant to the Trademark Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby (a) terminate the security interest created under the Trademark Security Agreement in the Collateral (including, without limitation, in the Trademarks set forth on the attached Schedule A), (b) release and relinquish its security interest in the Collateral (including, without limitation, in the Trademarks set forth on the attached Schedule A), and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Collateral (including, without limitation, in the Trademarks set forth on the attached Schedule A). The Collateral Agent agrees, or authorizes the Assignor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Assignor to evidence the release and termination of the Collateral Agent’s security interests in the Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
