TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made and entered into as of June 16, 2021 (the "Effective Date"), by and between Kadenwood Social, LLC, a Delaware limited liability company whose principal office is at 450 Newport Center Drive, Suite 550, Newport Beach, California 92660 ("Assignee"), and Sentia Wellness, Inc., a Delaware corporation whose principal office is at 1419 NW 14th Ave, Portland, Oregon, 9720 ("Assignor"). All capitalized terms used but not otherwise defined herein shall have the respective meanings set forth in the Asset Purchase Agreement (as defined below).

WHEREAS, this Assignment is made and entered into pursuant to the terms of that certain Asset Purchase Agreement, dated June 4, 2021 (the "Asset Purchase Agreement"), by and between Assignor and Assignee; and

WHEREAS, under the terms of the Asset Purchase Agreement, Assignor has conveyed, transferred, and assigned to Assignee, among other assets, certain intellectual property of Assignor, and have agreed to execute and deliver this Assignment.

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's rights, title, and interest, in and to the Acquired Marks, as defined in the Asset Purchase Agreement, and any associated goodwill thereof, including, but not limited to, the U.S. and foreign trademark registrations and applications, state trademark, trade name and corporate name registrations, domain names and the social media accounts set forth in the attached Schedule I.

2. Further Actions. Following the date hereof, upon Assignee's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Acquired Marks to Assignee, or any assignee or successor thereto.

3. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Acquired Marks. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

4. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means

of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

5. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


