**TERMINATION AND RELEASE OF GRANT OF
SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of August 2, 2021, and made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as agent (the "Grantee"), to **QUINCY NEWSPAPERS, INC.**, an Illinois corporation, (the "Grantor").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of November 2, 2015 by the Grantor in favor of the Grantee (the "Collateral Agreement"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Collateral Agreement was recorded at the United States Patent and Trademark Office on November 23, 2015 at Reel/Frame 5673/0875; and

WHEREAS, Grantee now desires to terminate and release the Collateral Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:

1. Definitions. The term "Trademark Collateral" as used herein includes all of each Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Collateral Agreement and terminates, releases and discharges its lien on and security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.
