RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of July 29, 2021, is executed by KAYNE SENIOR CREDIT IV LOANCO, LLC, in its capacity as Administrative Agent (in such capacity, “Administrative Agent”), in favor of WHITEBRIDGE PET BRANDS, LLC, a Delaware limited liability company (“Whitebridge”), WHITEBRIDGE PET BRANDS HOLDINGS, LLC, a Delaware limited liability company (“Holdings”), CARDINAL LABORATORIES, LLC, a California limited liability company (“Cardinal”) and GRIZZLY PET PRODUCTS, LLC, a Washington limited liability company (“Grizzly”, and together with Whitebridge, Holdings and Cardinal, “Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreements (as defined below).

RECITALS

A. WHEREAS, (i) Whitebridge, Holdings and Cardinal have, pursuant to that certain Trademark Security Agreement dated January 24, 2020, recorded in the United States Patent and Trademark Office (the “USPTO”) on February 3, 2020 at Reel 6854, Frame 0290 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Whitebridge Security Agreement”) and (ii) Grizzly has, pursuant to that certain Trademark Security Agreement dated March 1, 2021, recorded in the USPTO on March 1, 2021 at Reel 7206, Frame 0905 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Grizzly Security Agreement”, and together with the Whitebridge Security Agreement, the “Security Agreements”), granted to Administrative Agent a security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral (the “Security Interest”), including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Administrative Agent wishes to terminate and release its security interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby terminates, extinguishes, cancels, discharges and releases, without recourse, any and all right, title and interest, including its Security Interest in and to the Released Collateral, terminates the Trademark Security Agreement and reassigns the Released Collateral to the Grantor. The Administrative Agent authorizes the Grantor, or its designee, to record this Release with the USPTO and other applicable registry at the sole expense of Grantor.

Administrative Agent shall take all further actions, and provide to the Grantor and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor’s cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.


This Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.




