**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of August 2, 2021, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company (“Administrative Agent”) in favor of **AFFORDABLE CARE, LLC**, a North Carolina limited liability company with an address at 5430 Wade Park Boulevard, Wade II, Suite 310, Raleigh, North Carolina 27607 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated December 13, 2019 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on December 13, 2019 at the United States Patent and Trademark Office at Reel 6816, Frame 0034.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of its Collateral, including without limitation the Trademarks listed in **Schedule A** (collectively, the “Trademark Collateral”).

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
