**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of August 2, 2021 by **THE PROVIDENT BANK**, a Massachusetts chartered bank (in such capacity, together with its successors and assigns in such capacity, “Lender”) in favor of **UNCLE CHARLEY’S SAUSAGE COMPANY, LLC**, a Delaware limited liability company with an address at 1135 Industrial Park Road, Vandergrift, Pennsylvania 15690 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain IP security agreement dated September 9, 2020 (the “IP Security Agreement”) with the Lender, notice of which was recorded on September 10, 2020 at the United States Patent and Trademark Office at Reel 7071, Frame 0898.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted the Lender, under the terms of the IP Security Agreement, a security interest (the “Security Interest”) in favor of the Lender, in and to all of its Trademarks, including without limitation those listed in Schedule A.

WHEREAS, the Lender has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Lender hereby releases, terminates and discharges any and all of its interest in the Trademarks of the Grantor, including and all of the goodwill of the businesses with which the Trademarks are associated, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens. The Lender further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
