In accordance with the provisions of Title 8, Sections 251(g) and 264 of the Delaware General Corporation Law (“DGCL”) and Title 6, Section 18-209 of the Delaware Limited Liability Company Act (the “DLLCA”)

Pursuant to Title 8, Sections 251(g) and 264 of the DGCL and Title 6, Section 18-209 of the DLLCA, the undersigned limited liability company executed the following Certificate of Merger:

FIRST: The name of the surviving business entity is Tender Greens OpCo, LLC, a Delaware limited liability company (the “*Surviving Entity*”), and the name of the corporation being merged into the Surviving Entity is T.Y.P. Restaurant Group, Inc., a Delaware corporation.

SEVENTH: A copy of the agreement will be provided by the surviving entity upon request and without cost to any member of any domestic LLC or any person holding an interest in any other business entity which is to merge or consolidate.
