Trademark Assignment Agreement for Recordation

This Trademark Assignment Agreement for Recordation (“Assignment”) is made as of August 2, 2021, to confirm the transfer on November 30, 2020 (the “Effective Date”), by Travelport Technologies Holdings LLC, a Delaware limited liability company (“Assignor”), in favor of Travelport, LP, a limited partnership existing under the laws of the State of Delaware, United States of America, having its registered office at 251 Little Falls Drive, Wilmington, Delaware 19808 (“Assignee”).

WHEREAS, pursuant to the plan of dissolution of Assignor, adopted by the sole member of Assignor on November 30, 2020, Assignor transferred, conveyed and assigned all of Assignor’s technology and intellectual property assets, including the trademark registrations and trademark applications listed on Schedule 1 (the “Assigned Trademarks”) to Assignee.

This Assignment is being executed to confirm and memorialize in writing the earlier transfer of all right, title and interest in and to the Assigned Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged:


1. Assignor confirms (a) having transferred, conveyed and assigned to Assignee, together with any and all goodwill associated therewith, as of the Effective Date, all right, title and interest in and to the Assigned Trademarks, including without limitation (i) any and all claims and causes of action, whether accruing before, on or after the Effective Date, and the right to seek damages for the past, present or future infringement, misappropriation, dilution, or other violation and (ii) all rights to proceeds, income, revenues and royalties, whether accruing on or after the Effective Date, in each case, resulting from, arising out of, or otherwise with respect to the Assigned Trademarks and (b) that the Assigned Trademarks were transferred, conveyed and assigned to Assignee subject to certain liens granted by the Assignor to Wilmington Savings Fund Society, FSB, in its capacity as collateral agent (the “Collateral Agent”), under each of (i) that certain Priority Lien Security Agreement dated as of September 25, 2020, by and among the Assignor, the Assignee, the Collateral Agent and the other parties thereto (as supplemented or amended from time to time) and (ii) that certain First Lien Security Agreement dated as of May 30, 2019, as supplemented as of May 30, 2019, by and among the Assignor, the Assignee, the Collateral Agent and the other parties thereto (as supplemented or amended from time to time) (collectively, the “Prior Liens”). Assignor authorizes and requests that the United States Patent and Trademark Office record Assignee as the owner of the Assigned trade.
2. Assignee confirms (a) having received from Assignor, as of the Effective Date, all of the rights, interests, and obligations as set forth in Section 1 hereinabove (collectively, “Assigned Rights”) and (b) that the Assigned Rights were transferred, conveyed, and assigned to Assignee subject to the Prior Liens and the rights of the Collateral Agent under the applicable security agreements without any modifications, limitations, amendments, or changes to the same.


