**TERMINATION AND RELEASE
OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

July 27, 2021

WHEREAS, ELLEVATION INC., a Delaware corporation (“Grantor”), and WESTERN ALLIANCE BANK, an Arizona corporation (“Lender”) entered into an Intellectual Property Security Agreement, dated as of December 11, 2020 (the “Security Agreement”; capitalized terms used herein but not defined are used as defined in the Security Agreement), which Security Agreement was recorded with the United States Patent and Trademark Office on December 14, 2020, at Reel 007150, Frame 0090, for the purpose of collateral security for all indebtedness and obligations of Grantor to Lender arising under the Loan Agreement (as defined in the Security Agreement);

WHEREAS, pursuant to the Loan Agreement and the Security Agreement, Grantor pledged and assigned to Lender, and granted Lender a security interest in its intellectual property, including without limitation the Copyrights, Patents and Trademarks listed on Schedule A hereto (collectively, the “Intellectual Property”); and

WHEREAS, Lender has agreed to terminate and release its security interest in the Intellectual Property as herein provided.

NOW, THEREFORE, for valuable consideration Lender hereby terminates and releases its security interest in the Intellectual Property, including without limitation the Copyrights, Patents and Trademarks listed on Schedule A hereto, and Lender hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of Lender’s right, title and interest in and to such Intellectual Property, effective as of the date set forth above.
